### SHIPPING DEADLINES

The following dates are our deadlines for your freight to arrive in our main Sussex based Cargo Centre ready for export to OTC via our main consolidated sea and airfreight services:

SEA FREIGHT goods in by... 11th March 2024 1200 hrs\*

AIR FREIGHT goods in by... 22nd April 2024 1200 hrs\*

Please contact us if you anticipate that these dates may present a problem to you in order to discuss possible alternative arrangements. \* subject to confirmed move in date \*



### **PACKING**

Please ensure your equipment is packed in a strong, waterproof packing case, which lends itself to being re-packed after the exhibition. Please bear in mind that your exhibits will be in transit for long periods both to and from the exhibition and that cartons are not suitable to withstand the continued handling, which takes place during transhipment. EFI cannot be held responsible for any damage due to improper packing.

If requested, EFI can provide custom made re-usable wooden crates to your specification. Notice of at least a week will be required.

IPPC - Abbreviation of "International Plant Protection Convention";
XX - International Standardization Organization (ISO) two letter country code;

000 - Wood packing producing enterprise code approved by official plant quarantine authorizations in export counties or territories; YY - The phytosanitary treatment measures, Methyl Bromide Furnicating - MB. Heat Treatment - HT

WOOD PACKAGING REGULATIONS <u>Link to GOV website guidance</u>
Strict wood packing controls are applied and any wood packaging (including wooden pallets) must comply with the International Standard for Phytosanitary Measures (ISPM 15).

All wood packaging materials must be treated by either Heat Treatment (HT) or Methyl Bromide (MB) fumigation at the origin, and bear the Mark of the IPPC on two opposite sides of the wooden packaging material.

The Mark should contain the valid symbol approved by IPPC, country code, unique number of producer / treatment designated by the National Plant Protection Organization (NPPO) of exporting countries and treatment methods (HT, MB).

Where wood packing material arrives without the approved mark or with approved mark but is found to contain live harmful pests the cargo will be disposed of or returned to origin at the cost of the shipper.

Penalties/ additional costs in this case will be for the account of the exhibitor.

Please contact EFI at any time for advice/ further assistance with wood packing preparation.

#### **EMPTY CASE RETURNS**

EFI do not control the movement of empty cases at OTC. Although EFI representatives will be on hand to assist with the fastest possible return of empty packing cases, please note that this operation may take several hours. We strongly suggest that you leave the retrieval of empties to EFI.

We always recommend that a representative of your company is present to supervise the re-packing of materials on your stand. EFI cannot be held responsible for any items left unattended prior to, during or after the event.

### ON SITE POSITIONING

This refers primarily to large or heavy exhibits. EFI work closely with Freeman's, the official on site drayage contractor, to co-ordinate unloading and delivery of materials. Any large or heavy items (in excess of 500 kilos per single piece) that you plan to display may need to be positioned at an early stage during the move in period. If you can send to us in advance a copy of your stand layout, showing the piece of equipment and its intended location, we can make arrangements to place this in good time if need be.

# **DOCUMENTS REQUIRED**

A commercial invoice and packing list (CIPL) is required in order to proceed with Customs clearance and ultimate delivery. EFI will provide a format to used and it can be downloaded HERE

Please forward a copy via email prior to despatch of the goods and we will be pleased to advise of any amendments or clarification that U.S. Customs may require. The invoice must show a list of items included in your shipment (indicating make, model, serial numbers and country of origin where applicable) with a value equivalent in US Dollars against each item, and a total shipment value shown. US customs will not accept "Goods of no commercial value". Also note that the complete cargo description such as 'give-aways' is not acceptable.

#### **RESTRICTED CARGO**

Please note several categories of goods including textiles (e.g. T-shirts, hats, bags, carpets, ties etc) and certain categories of electrical equipment (including computers, TV's, DVD players etc) are subject to import restrictions. This does not necessarily mean that these goods cannot be shipped but please inform us as soon as possible if you plan to send such items in order we can check with local Customs and/ or ensure the correct documentation is raised. If you plan to ship any lithium batteries these will have to be packed, documented and shipped separately to avoid holding up the main freight consolidations

Food and Beverage products – please do not ship any food or beverage products. The requirements for entering these to the United States and are strictly enforced. These can and should be sourced locally.
