GENERAL NOTES

- Unloading /reloading rates based on ratio 1 cbm = 300kgs and are charged on whichever is the greater.
- All started cubic metres (cbm) will be rounded up to the first-round number, i.e. 1.2 cbm will be charged as 2 cbm.
- 1x Loading Metre = 5 cubic metres.
- This tariff refers to shipments up to gross weight 800 kilos, dimensions 200x100x180cms, for shipments over this weight and size please contact EFI for confirmation of costs.
- Packing material such as banding, shrink-wrap, bubble wrap is excluded but are available on request; please contact EFI should require these services.
- Please note that shipments booked via the EFI advance receiving warehouse will be exempt from overtime surcharges.
- Any unforeseen costs (incorrectly consigned goods) where additional costs to third parties are incurred will be passed on to the exhibitor at cost + 15% outlay fee.
- The rates in this tariff apply to the stated event only.
- All rates are also applicable to the outbound service.
- All rates are exclusive of VAT.

EXCLUSIONS

The following items are not included in this tariff...

Insurance, duties / taxes + outlay, hazardous cargo, LCL port THC, airline/ port/ warehouse storage/ demurrage, harbour maintenance, out of hours surcharges, late arrival surcharges, waiting time, document courier fees, deferments, on-forwarding/ return freight charges and any re-export costs (*unless stated*), if applicable. This tariff is based on current freight rates and calculated using current rates of exchange 09/06/2026. A CAF (currency adjustment factor) and/or fuel surcharge may be applicable should these factors alter at the time of show.

INSURANCE

We recommend that you have your goods fully insured against loss or damage for transit and the duration of the show. EFI is only covered for your goods under our BIFA 2025 Terms and Conditions which is limited and may not provide the full cover you expect. We therefore recommend that you insure your goods fully or extend any cover you may currently have.

PAYMENT TERMS

All invoices are payable on receipt. If you do not have an account with EFI we request credit card details to guarantee payment. On receipt of your invoice from EFI you can either pay via bank transfer or request payment to be taken from your card. Late /on-site orders received after the deadline carry a 35% late booking surcharge.
