FRIDAY 17th October

****Heavy lift/ Containers ONLY.** There is no unloading of stand materials on this day. Book with EFI to get your booking code.

SATURDAY 18th October

08:00 – 13:00 **EARLY ACCESS** for stand with early access approval from the organiser. All unloading during this time is by forklift and must be booked with EFI.
Code needed. 14:00 – 19:00 General Move-In for contractors

SUNDAY 19th October – general move-in

08:00 – 19:00 **General Move-In** for contractors

MONDAY 20th October

08:00 -16:00 **General Move-In** (contractors and exhibitors)

THURSDAY 23RD October

15:00 – cars and small vans – exhibitors only
17:30 – all vehicles up to 3.5 tons
19:30 – all vehicles

FRIDAY 24th October

08:00 – 12:00 **General move-out**
12:00 -14:00 ****Heavy lift/ Container load out** (code needed)

****During heavy lift, FULL PPE is required (including hard hats)**

At all other times, PPE is required (safety, high visibility vests and protective working boots/ shoes).

If you arrive on site without these, you will not be admitted to the hall.

All shipments for Intermodal Europe 2025 should arrive at the appropriate Spanish Port, Airport or directly into our advanced receiving warehouse **no later** than the dates shown below:

ADVANCED RECEIVING WAREHOUSE

Individual shipments less than 1000 kilos/ 5cbm should be delivered to the Intermodal advanced warehouse. EFI can arrange collection from your premises, or you may deliver to the IME Warehouse via your own carrier.

This service includes all transfers to and from your stand at Intermodal. There is no waiting time and no congestion. No need to book into the Fiera Barcelona traffic system.

Your delivery must be booked in and labelled appropriately.

Shipments must be booked in advance by submitting the Freight Order Form. We will send you confirmation of booking and your Intermodal Europe shipping labels.

DELIVERY DIRECT TO SHOW SITE

This event has a targeted move-in.

All direct deliveries to the venue need a vehicle booking/ slot time/ vehicle pass. Traffic marshals will control access to the unloading area according to time slots.

Do not deliver before your slot time, your shipment will be refused.
Shipments smaller than 5 cbm/ 1000 kilos go to the advanced warehouse.

All unloading during the heavy lift window will be by organizer approval only and must be undertaken by forklift & booked in advance with EFI Logistics.

All on-site handling must be booked by the deadline **Monday 22nd September 2025**
Late order surcharges are applicable after this date

You must book in your truck with EFI

A vehicle booking/ pass system is in place. All passes must be shown to access the unloading area at the venue. Passes are issued according to the move-in schedule.

We will send a site map with your vehicle pass.

CUSTOMS

EFI operate a Temporary Import Bond (TIB) for this event, allowing the temporary admission of exhibit materials without payment of duty and VAT. To ensure that this bond is protected all shipments entered under bond will be exported by EFI. We cannot hand over shipments under our bond to a third-party forwarder. If your shipment requires urgent export after the event, please advise us before the show so we can plan in good time.

We require a combined commercial invoice and packing list for customs clearance of international shipments. Please see next page for details and sample form.

PACKING AND CASE MARKING

All packaging should be suitable for transport and repeated handling. EFI recommend bolted, returnable cases for this purpose; nailed /screwed lids are not suitable as they suffer on opening and can become loose for transit. Any damage claims will be declined should packing be deemed not adequate.

Wood Packaging Materials from outside the EU must comply with fumigation regulations and be either heat treated or fumigated with Methyl bromide and carry the internationally recognized marking. Failure to comply with these regulations could result in the return of goods to origin at your expense.

Please ensure that each package is clearly labeled with Exhibitor Name, Stand Number and Intermodal Europe 2025 please e-mail EFI for a label format to print and attach to your shipment

COMMERCIAL INVOICE /PACKING LIST

We require a combined commercial invoice and packing list for customs clearance of international shipments.

This document must be completed and e-mailed to EFI for checking at least 3 days prior to shipment.

Notes for completing the CIPL:

- All entries must be in English language
- Shipper's address and EORI Number must entered
- Exhibitor and stand number shown
- Quantity, weight, dimensions packages/cases. If palletised, overall size /weight (not individual boxes).
- A full description of the items must be given.
Brand name, model number, serial number for machines, computer and hi-tech equipment.
- 10 Digit Customs tariff code must against each item.
- Origin must be shown against each item
- All values declared/ indicated on the shipping documents must be reasonable . "No Commercial Value" is not acceptable
- Items must be marked for temporary/ Permanent import
- Unit value and total value shown against each item
- If more than one page required, please indicated
page 1 of 3, 2 of 3 etc.

Once approved the document can be printed, date, signed and returned in PDF format.

EMPTY CASE STORAGE

EFI will remove all empty packing materials from the halls prior to final cleaning. Please ensure your cases are labeled with EFI empty case labels, available from our team on site. All items stored with EFI will be returned to stands after close of show and once the halls are cleared of visitors. We offer two services 'priority' and 'standard' service. Priority cases will be returned first, standard service starts once the priority service is completed. Please ensure you label your material; accordingly, we are unable to upgrade standard service to priority once the cases are in store.

For Health and Safety Reasons empty packing materials cannot be stowed on or around the exhibitor's stands, any packing material found in these restricted areas will either be destroyed or removed and stored by EFI at the cost of the exhibitor. Storage of empty packing on the show floor is strictly forbidden.

***Any untagged empty cases will be removed and stored at the priority rate.**

For those exhibitors requiring re-packing of exhibits at the close of the show, this will be started once all exhibitors are in receipt of their empty packing material after close of show.

HAZARDOUS /RESTRICTED GOODS

The shipper is responsible for providing EFI with relevant hazardous goods declaration forms or copies of export /import license documents if applicable. We cannot complete these forms on your behalf. Failure to declare such goods may result in penalties or claims, which will be for the account of the shipper. Hazardous or restricted goods must be packed according to IATA /carrier regulations. Please note that lithium batteries are restricted on aircraft, these restrictions currently vary per airline.

COURIER SHIPMENTS

We do not recommend the use of couriers for shipping international trade show material. Generally, courier companies are unable to arrange temporary import, therefore this could prove a costly exercise with the inclusion of duties and taxes. If you have a small shipment from within the EU then please utilize the advance warehouse, do not send courier shipments directly to the show site. The Fira is a large venue and they are highly likely to get lost. Please contact EFI before attempting to ship any goods by courier we can advise you.

INSURANCE

We recommend that you have your goods fully insured against loss or damage for transit and the duration of the show. EFI is only covered for your goods under our BIFA 2021 Terms and Conditions which is limited and may not provide the full cover you expect. We therefore recommend that you insure your goods fully or extend any cover you may currently have to include transit and duration of the event.

PAYMENT TERMS

All invoices are payable on receipt. If you do not have an account with EFI we request credit card details to guarantee payment. We will not charge the card unless you ask us to do or our payment terms are exceeded. On receipt of your invoice from EFI you can either pay via bank transfer or request payment to be taken from your card.

All services must be ordered in advance using the Freight Order Form by the deadline Monday 22nd September, orders received late or on-site carry a 50% late booking surcharge.
